THE SEEDS AND PLANT VARIETIES (PLANT BREEDER'S RIGHTS) REGULATIONS

APPLICATIONS FOR GRANT OF PLANT BREEDER'S RIGHTS

IT IS notified for general public information, that pursuant to regulation 16 of the Seeds and Plant Varieties (Plant Breeder's Rights) Regulations, the Minister for Agriculture gives notifications of applications for grant of plant breeder's rights herein specified.

The person entitled to make representations regarding the applications is either the breeder or successor in title to the breeder or any person having substantial interest or is in position to adduce material evidence as to the grant.

The representations may be made by lodging the original or certified copy of the deed of assignment; or lodging the original or certified copy of grant of letter of administration of the grant or such documentary evidence as will satisfy the authorized officer.

The representations or requests for a hearing concerning the applications or any matters on which the authorized officer should be satisfied shall be made by the person applying for the opportunity to make representations.

The representations or requests for a hearing concerning the applications should be made in accordance with regulation 17 of the Seeds and Plant Varieties (Plant Breeder's Rights) Regulations.

The application for the opportunity to make representations shall be made to the authorized officer who is also the Managing Director, Kenya Plant Health Inspectorate Service, P.O. Box 49592, Nairobi.

The application for the opportunity to make representations shall be made within thirty (30) days from the date of publication of this notice in the Gazette.

The processing of the applications for grants of the plant breeder's rights shall commence after the expiry of thirty (30) days and the publication of the schemes in the Gazette.

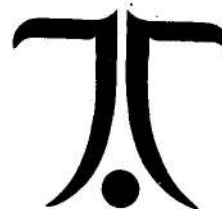

**IMPORTANT NOTICE TO SUBSCRIBERS

- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—
Kenya Gazette

"D 40. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m. on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) Ministries will be required to pay for the *Kenya Gazette* and to meet the cost of advertising in it.
