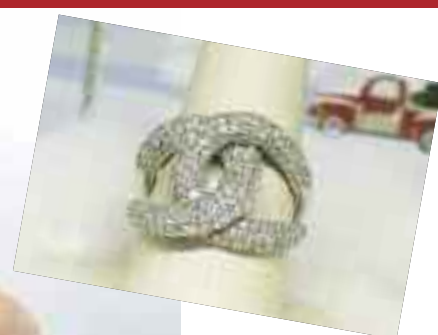

## More Analysis of GOP Runoff

Currently, congressmen/women win reelection at a 98 percent rate. The communist politburo does not have that high of a reelection percentage. Maybe we have more in common with the Russians than Washington CNN reporters think.

It is hard to get beat as an incumbent congressman. Martha Roby tried but even though she was the most vulnerable Republican incumbent congressperson in the country, she shellacked a former Montgomery mayor, one term congressman, and doggone good country one-on-one politician Bobby Bright. She beat him like a rented mule, 68-32.

Two years ago, she blatantly said she was not going to vote for the Republican nominee, Donald Trump, for President. Trump and the Republican Party are very popular in the 2nd Congressional District. It is one of the most conservative and GOP based districts in the nation. Currently, Trump's approval rating among GOP voters in the second district is 90 percent.

Well, young Ms. Roby, became an instant pariah in her district. She would have lost overwhelmingly had the 2016 GOP primary not just been over. There was an unprecedented, record breaking, number of write in votes against her in the November 2016 General Election.

It was assumed that whoever ran against her in this year's GOP Primary would beat her. She was scorned and mocked in her district and even uninvited to GOP events. Indeed, four viable men ran against her in the GOP Primary. She outspent them four-to-one and still only got 39 percent to Bright's 27 percent.

She pulled it out in the runoff for two reasons. Donald Trump endorsed her, which was manna from heaven. Trump is very popular in Southeast Alabama and the reason she was in the doghouse anyway was because she said she was not going to vote for Trump. If Trump forgave her, then folks in Andalusia figured they would too.

However, the big reason she won was because of the incumbency rule mentioned earlier. Washington special interest money stays with incumbents. The Washington money stuck with her like glue. She outspent Bright 9-to-1. It is impossible to overcome that kind of financial advantage.

She learned her lesson. Bet you won't see her involved in somebody else's race again. It was an arrogant and unnecessary faux pas. First of all, nobody

cares who a three term, backbench congressperson is going to vote for as president. Folks in a Republican district assume that you are going to vote for a fellow Republican.

The Agriculture race ended about as expected in the runoff. Rick Pate led Gerald Dial 40-to-30 in the first primary. Pate beat Dial 57-to-43 in the runoff.

Pate is a lifetime farmer and longtime Farmers Federation leader. The Alfa endorsement was critical in this race. They loyally supported him. Pate won even in the metropolitan counties. Alabamians inexplicably have a way of picking the farmer in this race.

The turnout in the GOP runoff was abysmal. It was around 12 percent statewide. However, in counties where there were local races, it was between 25-35 percent. All politics is local. Walker County had 25 percent turnout because they had a tough sheriff race. Marion had three local runoff races and voted at 28 percent. Marshall County had two local candidates running statewide, Will Ainsworth and Steve Marshall. They voted 19 percent.

In Alabama political history, Barbour County has been known as the Home of Governors, and indeed, six Alabama Governors have called Barbour County home. In the 80's and 90's Cullman County claimed two Governors, Guy Hunt and Jim Folsom, Jr. Of course, little Jim's daddy, Big Jim, was governor in the 1940's and 50's. That gave Cullman County three governors. Tuscaloosa has had three governors. They should rightfully claim Lurleen Wallace, who was born and raised in Northport. Only a few years ago, Tuscaloosa had a unique advantage of claiming the Governor Robert Bentley and Alabama's Senior Senator and most powerful politico, Richard Shelby, at the same time.

However, the results of the Republican Primary have propelled Marshall County into the limelight. Beginning with the next quadrennium, Marshall County will more than likely lay claim to both Lt. Governor Will Ainsworth and Attorney General Steve Marshall.

For generations the legendary Beat 14 in Elmore County was the Bellweather box in the state for predicting the governor's race and mirroring the results statewide. In recent years their clairvoyance has diminished. There is a new rival to Beat 14 in Elmore County, Patsburg in Crenshaw County has been getting it right for a while now. In the July 17 runoff, Patsburg got every race correct. As Patsburg goes, so goes the state.

## WHAT IS THE PROCESS AND CONSIDERATION IN CONFIRMING JUDGE KAVANAUGH FOR THE SUPREME COURT?

Since President Trump's selection of Judge Brett Kavanaugh currently of the United States Court of Appeals for the District of Columbia Circuit to replace retiring Justice Anthony Kennedy on the United States Supreme Court there has been a lot of discussion. Judge Kavanaugh is a relatively young man when compared to some current and prior Supreme Court justices and was a high school classmate of current Justice Neil Gorsuch. Judge Kavanaugh can make a significant impact on cases for many years to come barring significant health issues.

Currently appropriate Trump officials are working with Senators to encourage their support once the voting process occurs. The nomination has been sent to the Senate Judiciary Committee. Judiciary Committee hearings may be held in late August. Currently an FBI investigation is under way as with all nominations as well as investigation by those both for and opposing the nomination of Judge Kavanaugh to learn about his judicial leanings and background. For instance, Judge Kavanaugh is Catholic and Catholics are historically pro life and as well Kavanaugh clerked for Judge Stapleton of the 3rd Circuit Court of Appeals when Stapleton wrote an opinion restricting abortion rights in Pennsylvania. Should Kavanaugh be confirmed by the Senate Judiciary Committee then there will be a debate in the full Senate. Though possibly ambitious, it is hoped that a vote may take place in September.

It seems that the Senators in opposition have concern among several items over abortion rights, civil rights in general and the Affordable Care Act. Certainly there are Senators that oppose Kavanaugh's nomination because he is a Trump nominee, but they have also researched his opinions and have found them counter to their own. Senator Dick Durbin has in the past referred to Kavanaugh as the Forrest Gump of Republican politics.

Kavanaugh is seen by many as being more in line with the legal thinking of deceased Chief Justice William Rehnquist. Kavanaugh at one time applied as Rehnquist clerk but was not accepted. Judge Kavanaugh has clerked or worked for many Federal judges including Justice Anthony Kennedy whom Kavanaugh would be replacing. Kavanaugh worked for Ken Starr and was the principal author in the Starr report arguing for the impeachment of President Bill Clinton. Kavanaugh has also worked for the younger President George Bush.

Kavanaugh has argued only once before the United States Supreme Court and lost in a 6-3 decision. As a Judge, Kavanaugh has had fourteen decisions reviewed by the Supreme Court. Of those fourteen decisions, thirteen have been affirmed and only one rejected. It appears at this point in time that the majority of the Supreme Court justices and Kavanaugh have similar Constitutional lean-

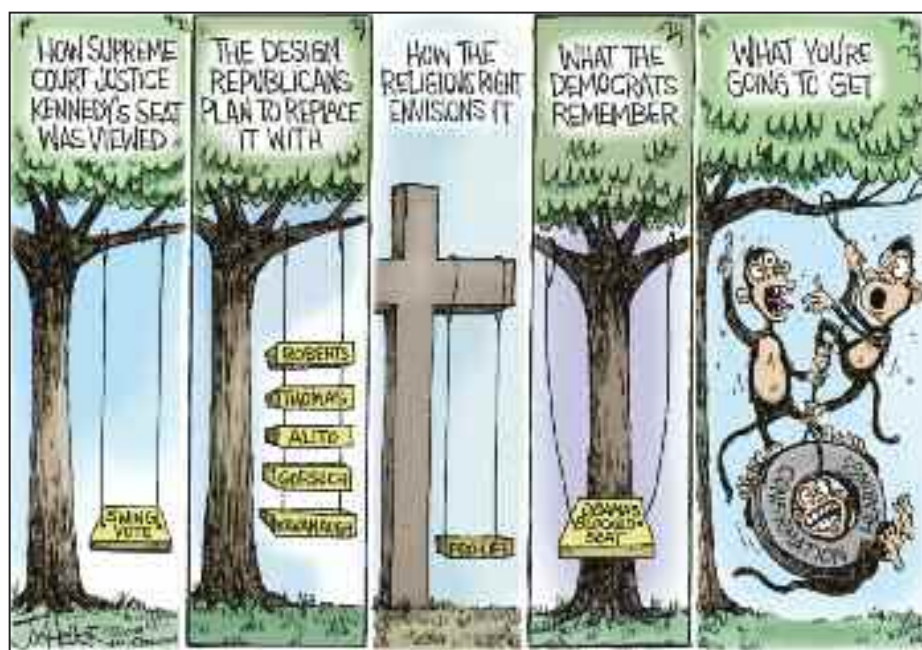
ings even though from time to time there have been surprises in the decisions by some justices that have seemed to veer from their historical holdings.

# The Education Station... By Bobbie Ames

Friends of the Gazette,

It is with great passion and concern that I approach this subject of our historical monuments, knowing the current attempt to destroy them and our History. The sons of Phyllis Schlafly, John and Andy Schlafly, wrote about this organized attempt across the nation to destroy our monuments and the stories that they have carried to generation after generation of American students. There is grave concern over these orchestrated attempts to obliterate our History. With their kind permission, we are reprinting their article of October 10, 2017, titled:

## Historical Monuments

### Rescuing Columbus from the Savages

John and Andy Schlafly ~ October 10, 2017

On the 525th anniversary of the European discovery of America, the 90-foot tall monument in New York's huge Columbus Circle escaped damage -- but only because the NYPD maintained a 24-hour honor guard during the entire 3-day holiday weekend. Police protection was needed because the violent left wing movement known as "antifa" had announced a nationwide campaign to "deface Columbus Day."

Statues left unguarded were not so fortunate. Around the nation in recent weeks, statues of Columbus have been toppled, splattered with paint, or otherwise vandalized. In downtown Los Angeles, a Columbus statue in front of the county courthouse was shrouded with a white sheet, ostensibly for its own protection, after the L.A. City Council voted to rename the paid holiday as Indigenous Peoples Day.

The Mayor of New York City, who was born Warren Wilhelm, but changed his name to the Italian-sounding Bill de Blasio, had let it be known that the monument in Columbus Circle was at risk. He has appointed a commission to review the political correctness of hundreds of monuments, plaques, and statues throughout the city.

New York's Columbus monument was built and paid for by Italian immigrants in 1892, to honor the 400th anniversary of discovery, around the time that Chicago was preparing to host the World's Columbian Exposition. Italian Americans were rightly proud of Columbus, but his voyages were actually sponsored and financed by Spain, his crewmen were Spanish, he spoke Spanish, and wrote his journals in Spanish.

Americans were already celebrating Columbus on the 300th anniversary of the discovery, in 1792, when a Columbus monument was erected in Baltimore. Despite the lack of Italian or Spanish people in the original 13 colonies, the English settlers recognized that Columbus's discovery of the New World was the event that made America possible.

Our nation's capital is the City of Washington, in the District of Columbia, honoring the two men who made our country. Columbus' name is reflected in many other places, including two state capitals (Ohio and South Carolina). For much of the 19th Century, the word Columbia was often used as an alternative to America.

As President Trump said in proclaiming the federal holiday, Columbus's voyages "undeniably and fundamentally changed the course of human history and set the stage for the development of our great nation."

On Columbus Day, Trump declared, "We honor the skilled navigator and man of faith for his courageous feat-- even in the face of extreme doubt and tremendous adversity."

What a contrast with the apologetic tone of Obama's proclamation one year earlier, which omitted any praise of Columbus or recognition of his greatness. Instead Obama whined that "we must acknowledge the pain and suffering of Native Americans" which he said has been "marked by too many broken promises, as well as violence, deprivation and disease."

By apologizing for Columbus as a man allegedly responsible for bringing pain and suffering, violence and disease to America, Obama was apologizing for America itself. Such ideas are far too common in our schools and colleges, where Columbus is wrongly accused of oppressing the native people with slavery, white supremacy, and even genocide.

The National Education Association, which supplies teachers to most of our public schools, adopted a resolution that "formal apologies are long overdue to the indigenous people of the United States." The fierce campaign against Columbus is motivated by hatred for America, and will continue even if his statues survive.

It is impossible to exaggerate how great Columbus was, and how much our world depends on what he accomplished. In the 2,000 years since Jesus Christ, it would be hard to name any one man who achieved so much for the betterment of mankind.

Columbus was, first of all, the greatest sailor and navigator who ever lived up to that time, as detailed by the famous historian Admiral Samuel Eliot Morison, himself a sailor who recreated Columbus's voyages. Yes, a Viking named Leif Erikson apparently landed somewhere in Canada about 500 years earlier, but Erikson left no permanent settlement or any trace that he was ever there.

Yes, there were people already living in North and South America when Columbus came. By comparison to the European explorers and settlers, however, America's native people lived in extreme poverty and brutality, lacking the skills that are necessary to build a civilized nation.

Yes, the European settlers brought new diseases such as smallpox that infected the native people (unintentionally, of course), but they were repaid in tobacco, which caused far more deaths among Europeans. Columbus wrote about tobacco in his journal on October 15, 1492, just three days after he arrived in the West Indies.

Among the gifts that Columbus brought to America was Christianity. Evangelization of the native people was a prime motivation for Columbus and his Spanish backers. Columbus gave Christian names to the places he visited, such as San Juan (St. John the Baptist) which became Puerto Rico.

And as we celebrate -- other holidays revered and cherished across America, we continue to see the monuments and the history represented in each one attacked.

#### Where Does It Stop?

"Sad to see the history and culture of our great country being ripped apart with the removal of our beautiful statues and monuments," President Trump tweeted last week. "You can't change history, but you can learn from it. Robert E. Lee, Stonewall Jackson -- who's next, Washington, Jefferson? So foolish!"

The mob violence did not stop with Confederate generals, but quickly extended to statues of ordinary soldiers, and then to other great historical figures. Christopher Columbus was attacked with a hatchet in Detroit, Abraham Lincoln was burned in Chicago, and the recently canonized Father Junipero Serra was spray-painted with the word "murder" at Mission San Fernando, California.

In Annapolis, Maryland, a sculpture of Chief Justice Roger Taney was hoisted from its massive pedestal and hidden in an undisclosed location as payback for Taney's opinion in the 160-year-old Dred Scott case. In Baltimore a Columbus monument erected in 1792 was attacked with a sledgehammer and in New York City, the Council Speaker has demanded a review of the massive, 76-foot-high sculpture at the center of Columbus Circle.

After President Trump asked "Where does it stop?," some amateur historians responded by claiming that Robert E. Lee was a "traitor" who committed "treason" against the United States. Such comments are ignorant and wrong, for the simple reason that the 11 Confederate states that Lee fought for are now part of the United States.

The Fourteenth Amendment, which became part of the Constitution in 1868, sets forth the conditions under which the defeated Southern states were readmitted to the United States on an equal basis with all other states. Nearly all who fought for Southern independence were restored to full citizenship on an equal footing with their counterparts who fought for the Union of North and South.

A previous generation of Americans, including those who actually fought in the Civil War, debated whether to charge General Lee and other rebels as traitors. They wisely decided not to go down that road, and it's too late to revisit their decision now.

Some Republican weak sisters -- the same people who timidly proposed civil unions as an alternative to gay marriage (remember how that turned out?) -- have offered a compromise. Instead of destroying the offending statues, move them to museums or Confederate cemeteries.

Gentlemen may cry peace, peace, but there is no peace: even cemeteries are not safe from the mob bent on the destruction of history. In Los Angeles, an online petition forced the Hollywood Forever cemetery to remove a 92-year-old hunk of granite that marks -- "lest we forget" -- the nearby graves of 37 Confederate soldiers.

In Madison, Wisconsin, the leftwing mayor removed a two-foot plaque marking the graves of 140 Confederate soldiers who died in a Union prison at Camp Randall after surrendering in battle. In Boston, where over 600 Confederates were held at Fort Warren, a granite slab bearing the names of 13 who died in prison was boarded up so their names cannot be seen.

History teaches what happens when a revolution gets out of hand, and it's not pretty. When law and order are overthrown, the mob rules.

When the French Revolution reached its peak of mob violence in 1793, the revolutionaries were not satisfied with slicing off the heads of their deposed king, Louis XVI, and his wife, Marie Antoinette. They also invaded the church of St. Denis, where French kings and queens for the preceding 1,000 years had been buried under monuments and statues that marked their lives and reigns.

The mob opened more than 100 tombs and scattered the remains so that the royal bones could never again be identified and reassembled. Then they marched to Notre Dame Cathedral, where they destroyed all vestiges of Christianity and turned the sanctuary into a "temple of reason."

In our hometown of Alton, Illinois, two Civil War-related monuments have stood for more than a century at opposite ends of town. On the east side, a flamboyant 110-foot column, topped by a winged sculpture of an angel and flanked by a pair of enormous eagles, honors Rev. Elijah P. Lovejoy, the anti-slavery newspaper publisher who died defending his printing press from a mob on November 7, 1837.

On the quieter western edge of town, a simple but elegant granite obelisk, 58 feet tall, marks the final resting place of 1,354 Confederate soldiers who died as prisoners of war in Alton's federal prison. More than 13,000 Confederate soldiers and civilians were imprisoned there under horrific conditions during the war, resulting in as many as six to ten deaths a day.

For as long as civilization has existed, the end of life on earth has been a time to remember the dead and to reflect on what their lives meant to us who survive. It's time for the grave robbers and defilers to stand down, or if they will not, to be put down by the law. *Requiescat in pace.*

## Write on Voter; Right ON!



The primary runoff is in the record books with over 87% percent of registered voters not participating in party elections they funded, some saying in fear of making an error for actual or accused 'crossover voting.' This may be the duopoly's desired result fueling the irony of claiming to want increased voter participation at the same enacting more impediments toward this end. The obvious answer is to prohibit taxpayers from paying for these party politics. If a party wants to use our public apparatus for determining their candidates on **general** election ballots (taxpayers **ARE** obliged to provide) then pay the user fee. Otherwise, since taxpayers pay for **BOTH** primaries (which have become party fundraisers) voters have a 1st Amendment right to participate in both. Sadly, no one expects just outcomes of this sort when jurists like Myron Thompson consistently fail to defend our civil rights in Alabama.

June 5th primary results were similarly dismal with 74% **not** participating even with a more complete slate of candidates to determine. While many are mesmerized by recent news reports and DC hearings to address foreign tampering in **our** elections (as we've done to other nations) slowly more good folks understand our system is indeed rigged and it is an 'inside job.' To be listed on the primary ballot one must fundraise for the duopoly parties - e.g., a Congressional seat currently requires **\$3,480** to place a name on the ballot. Note this **\$3,480** is **NOT** submitted to the Alabama State Treasury to offset expenses to make these partisan determinations. The low turnout, low information conveyed, hyper-gerrymandered election results are easier for extremists to manipulate and rig. So Trump 'clears the field' to use his words for candidate Clinton **or** he wins; heads he wins/tails he doesn't lose. Either way the oligarchs (of the same deleterious spirit as oligarchs across the globe) carry the day! Entertaining to watch Republican sycophants fall into line trying to be the Trumpiest for this long time NY Democrat - esp. here in the Heart of Dixie. The 'Pavlov Trump' ads are as predictable as the fear mongering Clinton/Obama ads of old.

Some found challengers (I've cited Thomas Casson's experience as a Republican candidate) don't get a 'fair shake' from the party and its operatives in the process. Casson said, "I fell for the trick in 2014. In 2018 I attempted taking on the system again experiencing some of the most restrictive ballot access laws in the country. I spent numerous hours away from my family trying collect the nearly 5,000 signatures to gain ballot access. People told me it would be easy. Candidate Casson further noted, "Only 8-15% of people approve of Congress yet they're reelected at a 90% rate. So what now? In the 3rd Congressional District 16 year GOP incumbent and Swamp creature darling Mike Rogers is seeking another term. I remember when GOP talked the talk about outsiders and term limits. On the democratic side former Miss America Mallory Hagan is nominee. People have already dubbed the race 'Beauty and the Beast.' I know voters can't wait for Rogers to get as close as possible to President Trump and the counter attacks from Hagan. Voters will also be treated to Rogers morphing Ms. Hagan into Nancy Pelosi. Rogers has refused any debates so there will be plenty of slick TV commercials on both sides." I'm guessing most of my readers are similarly weary of the extremists' campaign playbook feeding the bipolar result destroying our State and nation.

Pragmatists understand things will not change until voters rise up and force at least one of the duopoly parties to change. Voting for the **lesser of two evils** is what has 'progressed' us into the current mess. Casson asserted, "Politicos, pollsters, and the media all like things the way they are. No hard work on their part. If there is going to be a Swamp draining that people want, the angry and apathetic 75% are going to have to put forth some effort. I'm not talking about major work though. It's time to 'Make the Pen Great Again.' **We the People** can hack this broken system by writing someone for races where there are no good choices. We don't have to rely on super wealthy people and PACs to get involved and buy the system. I legally changed my name to Thomas Sick of DC Casson. Extreme maybe but it reflects what desperate times we are in. And by the way a name change is cheap! Here's the strategy but please don't tell everyone, we don't want to tip off the establishment. Pens are cheap to buy but they need to say "Write in or Vote SickofDC." The pens won't be provided by any Campaign or PAC. It's up to regular people that are fed up to take on the system. Citizens purchase pens and hand them out. Trust that the newly hacked system will get folks back engaged and that change can happen. The people of Alabama are much better than the two choices we are usually given. Let the games begin and let's have fun making the changes that are desperately needed."

The time may be ripe for Casson's **MPGA** (Make the Pen Great Again) strategy. Some of the runoff results were promising. Jeremy "Mr. EYG" Gray beat the old machine candidate in House Dist. 83 and shows promise to not be as easily captured if/when elected. Will Ainsworth's Lt. Gov. win signaled further hope those few who had the courage early on to make a stand against Felon Hubbard, et al will be further rewarded at the polls. Rick Pate's Ag Commissioner win also signals the days of old guard/machine candidates (Bright, Dial, Holmes, Knight, et al types) are losing ground. On the other hand, the results left some painfully poor duopoly choices or even worse only ONE/unopposed candidate in the November general election.

A local illustration from Lee County is the District 5 County Commissioner race. The best 'general welfare' pic of the four candidates in the primary came in a close third (blocked from the run-off) because the Fuller/Hubbard machine candidate and the big govt. Democrat machine candidate took the top two slots. Does it really matter to the average, productive citizen which special interest machine candidate won? Unopposed in the November election (doubtful, under these circumstances, Sec. Merrill will eliminate this general election race with only one party candidate as he's done in the past to install Rep. Lovvorn) the Fuller/Hubbard machine candidate wins. The lone voice against a corrupt county commission is silenced. Will the incumbent, who unsuccessfully ran for another race (very competitive due to the passing of Rep. Bandy) mount a serious write-in campaign? This account will sound familiar at the Statewide level to those who followed the AG election. Will Alice Martin mount a write-in campaign to increase voter participation when both duopoly AG candidates have made it clear they'll not discipline corruption in our State?

To those concerned about the so-called 'sore loser' law, Sec. Merrill sent a press release out driven by great interest in write-ins for the Dec. 2017 US Senate **Jones v. Moore** special election. Write-ins beat the margin of victory which

could have impacted the final result. Many saw Troy King's numbers plummet when touting the endorsement of Moore, who'd shown **non**-duopoly voters are not a fan on Dec. 12th. Merrill's release was intended to "provide much needed information" w.r.t. proper procedures for casting a "write-in" vote. Sec. Merrill asked folks to please share their press release information with the public to eliminate confusion on that Election Day submitted as follows:

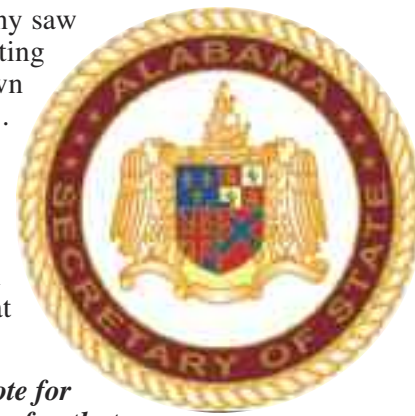
*"When the candidate you would like to vote for is not listed on the ballot, you may vote for that person by writing his or her name in the blank "write-in" box on the ballot. Each contest on the ballot has a "write-in" box. You must also shade in the circle next to that "write-in" box to ensure your vote is tabulated properly. In the event that the voter selects the "straight-party" option they may still "write-in" a candidate for any race they choose in the blank area designated for "write-ins". Each vote for a "write-in" candidate will override the "straight-party" vote only for the race with the "write-in" area filled in.*

*It is important to be familiar with the spelling of the name of the candidate for whom you intend to vote. In the event that the candidate's name is slightly misspelled, it must be close enough that the voter's intention can be reasonably determined upon review. The voter must use a full last name, but initials are acceptable for first and middle names.*

*All votes for "write-in" candidates will be counted in the event that the candidate is qualified to hold the office and not a fictional character. It is also required that the "write-in" vote be hand-written. Additionally, there are no existing stipulations that prohibit a candidate from being elected despite having unsuccessfully run for a party's nomination, which would normally apply due to Alabama's sore loser law."*

So there you have it - no sore loser problems if the law is followed. If successful, I forecast the next step by our duopoly in Montgomery will be to further impede our First Amendment Right to the ballot by prohibiting write-in votes, aided and abetted by a jurist like Myron Thompson who's shown such great disregard for our civil rights these past four decades. I'm hoping Becky Gerritson will show similar effort/wisdom as Candidate Casson to provide an outlet for voters who have foolishly stayed home/fail to participate with poor choices on the general election ballot (fed up with the duopoly in these Congressional races) to be counted at the polls. Start beating the margin victory and the duopoly loser will take notice. Sadly our low turnout (12.7% in this runoff), ballot restricted, hyper-gerrymandered, etc. bipolar results are communicating increasing **LESS** information - esp. when it offers two poor choices like McCain/Obama, Clinton/Trump, etc. to non-duopoly party voters.

**Postscript:** much correspondence on all the ineligible in Alabama State School Board races. I've heard nothing from Sec. Merrill nor if efforts in the courts are moving forward to not certify an ineligible winner(s). The most notable is the District 2 results where all **three** remaining duopoly candidates are ineligible if the '5 year window' law is followed. It appears most of those who did **not** vote for the ineligible in June didn't vote for **either** of the remaining Republican runoff candidates. Will Candidate Taylor mount a serious write-in campaign? It is yet another race positioned to beat the margin of victory if the thousands of voters angry at the ineligible decided to actually show and coalesce around a single write-in candidate they voted for in the primary who's not in violation of the 5 year window and currently eligible to serve.

If a candidate, in this case State Sen. Gerald Dial, is unable to adequately convey his own qualifications for office without resorting to the public exposure of his opponent's divorce filings of over 30 years ago, that candidate doesn't need or deserve to be in any political office

where he would wield enormous political power over others.

And while it's easy to say that nothing changes, the result of this runoff in at least the Agriculture Commissioner race gives me a sliver of hope that voters have had enough of the nastiness. Remember, it's ultimately up to voters to restore civility in elections – if we truly detest negative campaigning, we can send our own message by rejecting those who participate in the tactics we all allegedly bemoan.

## PRICE GOUGING

We are now well into the 2018 hurricane season, and a major storm may or may not hit us this year. But when one does, the news media will always mention a little consequence called "price gouging."

Reporters usually hype it up as something terrible, selfish, and even criminal. But when disasters strike, entrepreneurs are quick to respond by trucking in critical supplies and selling them for prices far above the norm. And people in need will be willing to pay for them.

Are these suppliers ripping off the victims? No, they are not. Yes, they do expect to make profits, just like people in any business. But their "excessive" prices are the result of the great expenses of quickly shipping the items over long distances and also risking delays, fines, and even seizures by law enforcement officials who somehow believe that providing critical essentials at elevated prices is a felony.

What if there were no "price gougers?" What if law enforcement apprehended and incarcerated every last one before he reached his destination? How would this action help the victims?

Imagine two identical coastal cities in Florida that have been severely damaged by a hurricane. One has "gougers" everywhere peddling everything from bottled water to plywood to tarps to generators at about 400% of their normal retail prices. The other has strict laws against them, and the local police are working overtime to make sure there is nobody around to sell these high-priced supplies. Which city would you rather live in? Think about it. Overpriced supplies, or no supplies? The police protecting property from looters, or routing out the "gougers" instead?

Anti-gouging laws not only hurt and obstruct the providers, they deprive the storm victims—people who are very willing to pay a few hundred dollars to save property that is worth thousands.

The buying and selling is strictly voluntary, like any other free market. Overpriced or not, people are not forced to buy anything. But some will need the items to save their property. The buyers and sellers will adjust their offers and prices according to their needs and mutual agreements. As long as officials step aside and get out of the way, the flow of commerce will take care of itself.

High prices have another beneficial effect. People will buy only what they need. If the local "Gestapo" mandates that prices be reduced to "normal"

levels, people with little need will exhaust the supply, and those with great needs will end up empty-handed.

Prices will always adjust themselves according to the fundamental law of supply and demand. When the supplies run short, their prices will rise. But the higher prices will entice more entrepreneurs from farther away to bring more. As new supplies come in greater quantities, the prices will decline. In a free market, they will soon fall to normal levels, and shelves once again will become adequately stocked.

In a free market, which is completely voluntary, there is no such thing as price gouging. Gouging can only occur if outside forces interfere with the supply or the demand.

If anything is monopolized, then gouging really does take place. In practice, monopolization is caused by one entity—government—all levels of government. It has the power to become a single seller. It also has the power to artificially create demand.

"How?" you ask. Would you like to get a passport? Where would you buy one? Walmart? Sears? No way. You have to go to your monopoly provider—the federal government. And you have to pay the asking price, whatever it is.

But wait. Do you really need a passport? If you plan to do much traveling outside of the country, you will. However, it wasn't always that way. A century or more ago, passports were not needed for international travel. But now, governments everywhere have created a need for them.

And they can gouge you for whatever prices they want.

And ditto for drivers' licenses, business licenses, permits, bail bonds, fines, penalties, traffic citations and many other things.

Welcome to the real world of price gouging.





# QUARTERBACK CONTROVERSY?

For the last seventy years, my attention has been on the game of football, especially college football. To my knowledge, during this time, never has there been such an obsession with who the quarterback will be at Alabama for the 2018 football season. Alabama fans are apoplectic. Some are actually being counseled for this unusual disorder. A number of sports writers in the state are providing fodder for this addictive behavior. What makes the quarterback situation at Alabama so puzzling is that there is almost always a quarterback controversy at Alabama as well as many other college football teams every year. The following few paragraphs will try to expose the folly of having apoplexy over the situation at Alabama.

He look at me menacingly and said, “Are you telling me that the players at Alabama have been wearing different colored socks? I answered, “Yes coach, some wear white socks, some wear black socks, and on rare occasions red. He countered, “That won’t be a problem. Next question.”

So far there has been only one player during the Saban years to break this tradition. That was Jalen Hurts, who wore a solid crimson stocking on his left leg through the entire 2017 season. He also wore a “medusa” style hairdo for two years. After the freshman from Hawaii **Tua Tagovailoa** pulled out the championship game last year in which Hurts had been ineffective, Hurts cut his hairdo.

It is my opinion that Coach Saban will choose to play both Tagovailoa and Hurts. There is an old axiom in football that says “if you have two quarterbacks, you don’t have any.” Someone made that up who never had two great quarterbacks. In my short coaching career, we were lucky to have 3/4 of a quarterback. Alabama has the best “problem” that they have had since Saban became coach in 2007. There is no controversy at quarterback. Don’t forget that Jalen Hurts, as a freshman, won the national championship for Alabama in 2016. With time running out and Alabama trailing Clemson, he scrambled for a thirty-five yard touchdown giving Alabama the lead, with only two minutes left on the clock. With Alabama’s vaunted defense, game over? No, the defense allowed **Deshawn Watson** to drive the field and complete a short out route in the end zone with six seconds left. A field goal would not have won it for Clemson. Alabama’s defense lost that game and not Jalen Hurts.

Now, let’s look at some other teams who are having this same struggle, not knowing which quarterback they will eventually go with. Clemson comes to mind first. The Clemson fans are not the least bit interested in who the quarterback will be at Alabama. A large part of the football fans along the Southeastern Seaboard, especially the state of South Carolina, are beginning to act like Alabama fans.

There is much consternation among these fans over who Clemson’s quarterback will be. **Kelly Bryant** took Clemson to its second straight play-off following in the footsteps of Deshawn Watson, who edged Alabama in 2016. The 2017 play-off game did not go so well for Clemson. Alabama had their way with the Tigers in the semi-final game. How does **Coach Dabo Swinney** bench Kelly for a hot shot freshman, who incidentally has already caused two Clemson quarterbacks to transfer? True freshman **Trevor Lawrence** (6-5, 210 lbs.) has the ability to start at 90% of D-I schools. His best assets are his arm strength and maturity. With the latest success of the Clemson program under Swinny, the Clemson fan base is becoming as fanatical as Alabama’s. The majority of the fans want Coach Swinney to kick Bryant down the road and start Lawrence. Does this sound familiar? This is just as big of a deal in South Carolina as Alabama’s fan base wanting Saban to go with the Hawaiian Heisman candidate, Tua. Can you believe that some publications have placed Tagovailoa as high as fifth in the pre-season Heisman poll for 2018? He has never started a game!

## GEORGIA

Georgia really has a “bad” situation. **Jake Fromm** (6-2, 225 lbs.) led the Bulldogs to the national title game last year as a freshman. He did it with the flair of a veteran. How can **Coach Kirby Smart** kick Fromm to the side for the “new kid on the block,” who is even more heralded than was Fromm? Fromm “almost” led Georgia to the national championship last year. But, he didn’t win it.

So Georgia fans are all excited about this new guy who could finish the job. Incoming freshmen, **Justin Fields** (6-3, 225 lbs), is the fan favorite to take Georgia all the way to the “promise land” this year. This is the same battle that is going on at Alabama and Clemson. “Big shot” alums are in Kirby’s ear about making the change. Does this sound familiar?

## TENNESSEE

Tennessee has its own controversy going on. The difference in Tennessee and Alabama is that the Vols may improve in 2018 and still finish 5-7. But, the demise of the excitable **Butch Jones** has brought hope to Tennessee. Jones was uprooted by Saban disciple, **Jeremy Pruitt**, who was the Tide’s defensive coordinator in 2017. Unrealistic expectations have gotten the fan base believing that the “Glory” of Tennessee football is just over the rainbow. However, Coach Pruitt must decide if he can go with sophomore **Jarrett Guarantano** (6-4, 210 lbs.), called the quarterback of the future in his freshman year. Or should he please the fans and look elsewhere. Last year Guarantano took a beating, but he showed signs of “greatness” even though he only started seven games in 2017. Of course, **Tom Brady**, would have looked bad playing behind the Tennessee offensive line last year. A graduate transfer from Stanford has brought new enthusiasm and new controversy. **Keller Chryst**, who was 11-2 as a starter at Stanford, has the Volunteer fan base frothing at the mouth with the possibility of benching last year’s starter in favor of the new guy. Although, neither quarterback could start at Alabama, Clemson or Georgia, the money makers in Knoxville are hyped up for a change. They see that Tennessee football can become Tennessee football once again. They are hyperventilating over the Tennessee quarterback situation. However, they are probably a slight bit interested in what is going on in Tuscaloosa. Tennessee will be fighting for nothing but pride this year, but they will be fighting!

## MICHIGAN

Unlike Alabama, Clemson, Georgia and Tennessee,

the situation in An Arbor, Michigan is becoming what I would describe as “reverse enthusiasm.” **Jim Harbough**, an outstanding Michigan quarterback in his own right, was lured by the right price for seemingly the right situation. Alma Mater Michigan has gone through coaches like shoppers through a supermarket. The team with the most wins by any college football team in history was floundering under its own notoriety. Favorite son, Jim Harbough, was supposed to ride to the rescue under a wave of enthusiasm and a fat contract. He was a “Michigan Man”, whatever that is. His first three years have been marred by close losses to Ohio State and Michigan State among many other losses. Coach Harbough is winning, but not enough for the Maize and Blue alumni and fans, of which Michigan has millions. The powers that be did not expect this from the vociferous and publicity hunting Jim Harbough.

Talk about a quarterback controversy, going into Harbough’s fourth season at Michigan, it has become apparent to his base that he is simply human after all. Michigan will have to beat Ohio State and Michigan State this year or the weary fans of “mighty” Michigan could be calling for a fresh start with another coach. “The Quarterback” has not been able to recruit a quarterback that can win at Michigan. You’ve heard of them. Well, it looks like Jim Harbough is going down or up with a graduate transfer. Patterson may be the piece of the puzzle that he needs. Michigan has been good defensively under Harbough. With a good football player at quarterback, the Wolverines may just go to the Rose Bowl this year. Unlike most people, I hope that they do!

Back to the original question. Does Coach Nick Saban start a quarterback who has only lost one game in two years? I can not “credit” Jalen Hurts with the loss to Clemson in the 2016 national championship game. I put that on the defense. Or, does Coach Saban roll the dice with a guy who has never started a college football game? That’s it, other than mop up duty. Tua has played one half of football in a critical situation. Even so, he did look like the incarnation of **Kenny Stabler**. Or, do you take the money plan by playing both. If it is your business, what would you do?

*The interesting thing to me about this “monumental controversy” at Alabama, Nick Saban can’t make a bad decision!*

# Woods & Waters

## with Steve



**Deer Harvest numbers have changed over the last few years.**

I hope all of you fine folks had a wonderful 4th of July! The heat's been cooking us all this month, but it's still only the start of Summer. Make sure all of you stay hydrated, stay in the shade, and stay cool!

Over the last year or two, I've gone out of my way to mention all the nasty sort of things deer and other critters have to deal with in order to survive. Between the obvious stuff like habitat loss, disease, predators, and the lovely Alabama weather we get from time to time, there's also the elephant in the room; hunting.

Well, sure, it's plainly obvious that the deer herd is thinned out by hunting. The real kicker there, though, is that it's far more complicated than just hunting them. QDMA's been collecting data on deer harvests for decades, and the numbers are pretty interesting to see. Kip Adams of QDMA wrote up a great summary online, and I'd like to make a mention of several of those points.

For starters, we're experiencing a pretty big shift in harvest ratios. Back when QDMA got started, harvesting antlerless deer wasn't really pushed for. Big Bucks or head on back home was the ticket back then. QDMA, however, pushed for more harvesting of antlerless deer. Since then, the amount of antlerless deer harvested has outstripped the number of antlered deer being brought in. Obviously, we're not talking about, "if it moves, it gets shot," type of hunting. That's just plain crazy. Instead, harvesting antlerless deer can help stabilize the deer herd in an area, for multiple reasons.

First, the resources available in a deer's habitat are limited. A specific plot of land can only support a specific number of critters, after all. Second, a limited population provides better disease control as opposed to a deer herd that's increasing in number like crazy. The less deer around, the less likely a terrible illness will go around the herd. Third, despite all of the things working against them, deer are pretty good at repopulating. Allowing the population of breeding does to keep climbing can lead to overpopulation in a hurry. A healthy herd size helps everything.

There's another, interesting tidbit that comes from a good harvest of antlerless deer; meat. Mr. Adams points out that from 2003 through 2016, there's a sharp drop off of 24%, or 870,842 antlerless deer, or to put that number in tasty perspective, we're talking 174 million venison meals. That's a whole lot of food that could do some serious good for folks who need it. To make up for the lack of meat coming in, you gotta replace that protein with more, different protein. Think cattle, pigs, chickens, or even soy fields. Either way, those enterprises can and will interfere with both deer habitat and populations, as well as other critters.

Speaking of doing some serious good with that grub, there's always the option of donating venison from a harvested doe. Most processors can help you with that, or point you in the right direction. If you're hunting area is in need of population control, you can always harvest that extra antlerless deer, and donate that venison to help out the needy folks. We Hunters are a social, responsible group to begin

with, so this kind of thinking oughta fall right into everybody's wheelhouse.

I'm not gonna tell you to not harvest that trophy buck that waltzes on past your tree stand this year, for sure. But a key tenet of what QDMA does is maintaining a healthy deer population in order to ensure those deer are still there next season, and every season after. Alabama's a hotbed for deer population, and if we're not careful, we'll be overloaded with Whitetail Deer again. If you're concerned with the deer population on your property, you can always start preparing for your October surveys.

As for me, I'm gonna evaluate the needs of the areas I hunt in the coming months, and I'll make my decision then. I just know that going forward, I might wind up passing some venison on to somebody who could use it. Again, I urge all my fellow Deer Hunters to consider doing the same. So get out there, get those deer counted, clean out that freezer for the harvest to come, and go get 'em!

I grabbed a red wasp between my index finger and middle finger. It felt like someone was poking a pin in the side of my finger. It looked like it got my three times. My hand swelled up and looked like I was wearing a catcher's mitt.*

*Today is Saturday the 14th, which to some people is worse than Friday the 13th. So far though my hand is looking more normal, just itches. I went out and picked a gallon of figs with wasps flying around. It looks like we are going to have a break in the heat. A break in the heat is always welcome. There is the sound of thunder outside and if it rains it will add to the five plus inches of rain we have had since I got stung.*

As I have mentioned before, our kitchen is not conducive to canning, because of the lack of adequate cooling and ventilation. But we still have managed to can about 400 jars of plum, fig, pear, chipotle raspberry and strawberry jams, including jars of grape, and apple jelly, and my sister's favorite, orange marmalade. There will be much more fig and strawberry jam to can and I tasted some cherries with dinner at a friends house and they were delicious and I hope they will can well.

There are five fig trees within a mile from my house. And it seems I am of the few that love figs. I started eating figs when I lived in Turkey. They were dried and strung together with straw in a ring. You could untie the ring and pull a fig off and eat it or like I did just eat it off the ring. Dried figs are super sweet, much more than fresh figs. You have sweetness that overwhelms the flavor of the fig, but to a 12 year old, they were heavenly. Now I keep some fresh figs in the refrigerator when available and I grab a few as I walk past. And when I am working outside in the yard, I will find a few plump figs on the tree and pick myself a tasty treat. But fresh figs are not super sweet.

I found a recipe to take my fresh figs and turn them into fresh sweet appetizers or a wonderful snack. The recipe comes from [www.melaniecooks.com](http://www.melaniecooks.com). She calls it a side dish; I call it my new snack and breakfast topping..

## ROASTED FIGS

### Ingredients

- 12 fresh figs
- 4 tablespoons sugar
- 1 teaspoon cinnamon



### Instructions

1. Place oven rack in the top most position in the oven.
2. Preheat oven to broil.
3. Line a baking sheet with foil and spray with cooking spray.
4. Cut the figs lengthwise.
5. Put the sugar and cinnamon on a plate and mix to combine.
6. Dip each fig half in the cinnamon sugar mixture on both sides, then put on the baking sheet, cut side up.
7. Place the baking sheet on the top rack of the oven
8. Broil for 4 minutes or until the cinnamon sugar starts to bubble and caramelize.

Let cool slightly as to prevent from developing second degree burns on the roof of your mouth.

Serves 4

Now, I figure that the figs will be a perfect addition to your breakfast. It has been said, over and over again, fresh fruit for breakfast is good for you. So what will go with the fresh fruit? A topping of Roasted Figs on your French toast will be a perfect breakfast.

But you look in your refrigerator and you are out of milk. Oh what to do? If it is anything like our house there may not be any milk but there is always ice cream. Milk goes bad but ice cream freezes and hides in the freezer for months; at least in my house. My wife buys vanilla ice cream for a dessert we will bring to Supper Club or the grand-kids are coming for the weekend. Since I like every flavor of ice cream except vanilla there will always be a half gallon carton of vanilla ice cream in the freezer. Since the grandkids will be here for a weekend, there will also be leftover bread in the freezer. You now have the makings of an easy breakfast.

I don't know how I came upon this recipe or how I came upon things to do with leftover ice cream. But I found scores of recipes that call for different flavors of ice cream to be used in pound cakes, cupcakes, icing, milkshakes, skillet cookie sundaes, deep fried chocolate bars, floats, waffles, funnel cakes and the surprise ice cream tacos. So here is the other part of your breakfast. This recipe comes from a blog Two Peas & Their Pod.

## ICE CREAM FRENCH TOAST

### Ingredients

- 1 cup vanilla ice cream melted
- 3 large eggs
- 1 teaspoon vanilla extract
- ½ teaspoon ground cinnamon
- 8 pieces Texas Toast of your favorite bread, just not pumpernickel or rye.

### Instructions

1. Preheat griddle (350 should do it)
2. In a shallow baking dish or pie plate, combine the melted ice cream, eggs, vanilla, and cinnamon. Whisk until blended. Dip both sides of each slice of bread into the mixture, allowing the bread to soak up some of the mixture.
3. Spray the hot griddle with cooking spray. And place the bread on griddle until golden brown on side and somewhat crispy, 3-4 minutes should do it. Flip and do same on other side.
4. Serve hot and if desired add toppings; Butter, Maple syrup, berries and DO NOT forget the Figs.

Serves 4-6



I buy lean beef hamburger meat and mix it with ground pork sausage to make patties for hamburgers and breakfast sandwiches to take to work. If I mix the pork sausage with the hamburger, I can use it for either meal. And as usual I spice it up enough that it goes with either breakfast or lunch or dinner. I don't blend the meats for a healthier patty but for a tastier patty. I saw an article about a hamburger blend that is being used in restaurants and even in fast food chains.

But instead of mixing sausage with the hamburger, they are mixing ground mushrooms into the beef. There are several takeaways from this; by replacing beef with mushrooms, the fat content of the patty is reduced, and fiber is increased, helping fast food chains and restaurants claim they are serving healthier meals. To make a home blended meat add about a third of a cup of ground button mushrooms to ¾ of a pound of ground beef. If you are one that is concerned about the beef industry's impact on the environment, a study by the World Resources Institute claims that if 30% of the beef in every hamburger in the United States was replaced with mushrooms, it would have the same affect as removing 2.3 million cars for the roads. Although, when you top your "healthier blended patty" with bacon, cheese and mayonnaise, your healthier item just got run over.

If you want to try an entree with a blended ground meat or a spiced ground beef, this next one has a lot going for it. Peppers, sherry, raisins, green chilies, cinnamon, and stuffed olives. This also gives you a chance to work with mild peppers. They may lack the heat but have distinct tastes. This is a recipe that I can adjust the type of peppers I use according to the amount of heat I want in the dish. I can add chopped jalapenos to the Hatch chilies in the stuffing and even using jalapenos stuffed olives, or a ground habanero for fun.

## POBLANOS STUFFED WITH SPICED GROUND MEAT

### Ingredients

*NOTE: If you are using blended ground meat, the mushrooms will release water when cooked, and the canned tomatoes are packed in juice. The stuffing for the poblanos should not run out of the peppers and the tomato sauce should be a little thinner than ketchup.*

- 6 large poblano chilies
- Cooking oil, for frying
- 1/2 cup dry sherry
- 1/2 cup golden raisins
- 1 (4-ounce) can (Hatch) green chilies, peeled, drained and chopped
- 2 teaspoons ground cumin
- 1 pound ground beef
- 1/4 cup water (if using a mushroom/ground beef mix; reduce to amount of water. Mushrooms will release water



while cooking)

- 1 onion, chopped fine
- 5 ounces pimiento-stuffed olives (about 1 cup), sliced
- 2 large cloves garlic, minced
- 1/2 teaspoon cinnamon
- 1/4 teaspoon ground cloves
- 1 teaspoon salt
- 1/2 teaspoon fresh-ground black pepper

Light Tomato Sauce  
(see recipe below)

### Instructions

1. Make a 1 1/2-inch lengthwise slit near the stem end of each large poblano. In a large, deep, heavy frying pan, heat 3/4 inch of oil until very hot but not smoking. Fry the poblanos in two batches, turning once or twice, until they are blistered and a dull green color, 3 to 4 minutes.
2. When the poblanos are cool enough to handle, peel them. Remove the seeds through the slits; do not tear the flesh.
3. In a small saucepan, heat the sherry until hot. Add the raisins and remove from the heat. Let sit for about 20 minutes.
4. Heat a large, heavy frying pan. Add the beef and the water and cook over moderately high heat, breaking up the beef with a fork, until it loses its pink color, about 2 minutes. Stir in the onion, olives, garlic, cumin, cinnamon, cloves, salt and black pepper. Stir in the canned green chilies and the raisins with the sherry. Cook, stirring, until the onion softens, about 5 minutes.
5. Heat the oven to 375°. Lightly grease a rimmed baking sheet. Carefully stuff the poblano chilies with the ground-meat mixture. Place on the baking sheet, stuffed side up, and bake until heated through, about 7 minutes.
6. Heat the tomato sauce. Spoon the sauce onto six individual plates or a large platter. Arrange the chilies on top and serve.

### Light Tomato Sauce

- Two 28 ounce cans of peeled plum tomatoes
- 3 cloves garlic, minced
- 3 tablespoons cooking oil
- 1 teaspoon salt
- 1 onion, chopped fine
- Pinch sugar, if needed

1. In a heavy medium saucepan, heat the lard until very hot but not smoking. Add the onion and garlic and cook over high heat, stirring, for 1 minute. Reduce the heat to moderately low and cook, stirring occasionally, until the onion is translucent and slightly softened, about 5 minutes. Stir in the tomatoes and salt. Bring to a simmer and cook for 5 minutes. Taste and, if the sauce seems too acidic, add the sugar. Remove from the heat and let cool
2. Transfer the sauce to a blender or food processor and purée

Serves 6

## IF YOU ARE YOUNG AND LOSE A PARENT

Social Security is here for young people when a parent passes away. We know that the loss of a parent isn't just emotionally painful; it can be devastating to a family's finances. In the same way that Social Security helps to lift up the disabled and elderly when they need it, we support families when an income-earning parent dies.

In 2017, we distributed an average of \$2.6 billion each month to benefit about 4.2 million children because one or both of their parents are disabled, retired, or deceased. Those dollars help to provide the necessities of life and help make it possible for those children to complete high school.

You might ask, who can get child's benefits? Your unmarried child can get benefits if they're:

- ✓ Younger than age 18;
- ✓ 18-19 years old and a full-time student (no higher than grade 12); or
- ✓ 18 or older with a disability that began before age 22.

To get benefits, a child must have:

- ✓ A parent who's disabled or retired and entitled to Social Security benefits; or
- ✓ A parent who died after having worked long enough in a job where they paid Social Security taxes.



Benefits stop when your child reaches age 18 unless your child is a student or disabled.

Within a family, a child can receive up to half of the parent's full retirement or disability benefit. If a child receives Survivors benefits, he or she can get up to 75 percent of the deceased parent's basic Social Security benefit.

There is a limit to the amount of money that we can pay to a family. This family maximum is determined as part of every Social Security benefit computation. It can be from 150 to 180 percent of the parent's full benefit amount. If the total amount payable to all family members exceeds this limit, we reduce each person's benefit proportionately (except the parent's) until the total equals the maximum allowable amount.

### *Never Assume You Have The Luxury Of Time*

Travis came into my life in 1990, when he was two and I was 18. His mother was not involved at that stage in his life and my life had not prepared me for being a stepmother. But I changed my schedule at AUM, and switched from working nights at Country's Barbecue to working days at Colonial Bank. I would drop Travis off at daycare before 8:00 and pick him up just after 5:00.

Up until now, I don't think I have ever written a word about those years of my life. It is not as if 18 to 23 didn't exist, but they weren't easy years. I did the best I could where Travis was concerned, but the marriage was destined to fail, even after adding a daughter. His dad returned to Illinois shortly after the divorce and Travis, who was then eight, naturally went with him.

That's what happened. That was the reality. I don't know how to spin it into anything other than what it was. Travis grew up. And I grew older.

I can't remember when we started messaging. It was years ago. He sent me a picture of him and me together from when he was little. He said he carried it in his wallet still.

I was happy that he seemed happy. Life had taken him from Illinois to Texas to North Dakota. From North Dakota he moved to California. I did not pry into his personal life, but I took it to be work that provoked the recent move. He liked to work. He was adventurous. Skydiving thrilled him. Speed did not scare him. Little did he know he was a bit fearless. Rules and limits weren't top priority for him, but it didn't come across so much as rebellion. It had evolved it appeared, into strength and confidence. I was proud of him.

I don't know what happened in California. He did not seem content there. Jokingly he had said it wasn't the place it was the people. He expressed interest in living a quiet life in the country.

In late May and early June there was a series of messages I didn't quite understand. He asked if I could remember being his mom and I told him I could. He wanted to know about a letter left on the Christmas tree when he was young. He said, "But I know it was from you." This letter was significant to him. And it prompted him for whatever reason to express his thoughts further to me. He was so open and sincere that I did not have the heart to tell him the letter was not from me. He said, "I have a lot of good memories about you and your family." I told him there would always be a place for him at my table and a space in my heart. I also told him how I had always felt if I had been older and had more life experience that I could have been a better mom to him. To which he replied, "Well I don't have any bad memories so that's a good thing right? Lol. That's part of why I always tell you Happy Mother's Day every year. When I think about Mom I think about you, and when I think about my childhood I think about being in Alabama."

I did sense that his openness that day was somewhat unusual. I asked him if everything was okay. He said, "Life's been a little rough, but I really can't complain. There are people who have it worse." He thanked me for asking.

Other than an exchange of simple, "good mornings," it would prove to be our final conversation.

Travis Christopher Saferite chose to leave this life Friday, July 13, 2018, in the same way in which he lived – on his own terms. He was 30-years-old...and leaves a permanent emptiness.

## *Southern Gardening*

*Potpourri for August by Peggy Givhan*

The dog days are upon us which usually conjures up hot, sultry days and nights. The term is of ancient origins. The Romans called these humid days "dies caniculares" which they associated with the Dog star, Sirius, the brightest star in the constellation of Canis Major (large dog). This constellation is prominent in the skies this time of year. And speaking of stars, let's look to the garden to see what star is sparkling during these "dog days".

Most summers the beds sparkle with masses of vinca, white, bright pink, or red, but this summer vinca has been a disaster. Even with the Sprinkler systems off,

the vinca has literally rotted in the ground because of all the rain. Vinca prefers a drier condition with plenty of sun. Begonias just disappeared with the rains. Also my lamb's ears have all but turned ash gray with soggy boggy leaves. But all is not lost. My stars are salmon dwarf canna lilies, yellow canna lilies, and bright orange canna lilies. Also, Pacific Giant zinneas are blooming their heads off, ginger

lilies, both the white and peach, have made a great showing, and my old fashioned phlox have been terrific. Plumbago and other woody stemmed tropicals have performed well under these conditions since they do not need full sun. I planted a clump of bright yellow Inca marigolds just for accent, and wish I have planted more. They love wet feet and have thrived with all the rain, but had to dead head them more often. Another star has been Torenia or the wishbone annual, mainly the dark purple variety.

### **Garden Herbs**

I have many types of herbs in pots that I use constantly in the kitchen. Over the years, the herbs that have performed the best are those I started from seed. Many times and many dollars later I have noticed the herbs purchased in garden centers bolt much earlier than the seed grown ones. I have heard that some nurseries put growth retardants on the plants so they will last longer and look

better in the flats. Chives are very easy to grow either in pots in beds. They do multiple year after year, so thin them out before they become too invasive. Any type of basil, fennel, dill are easy to grow from seed. Parsley both the flat and curly is also in that category. Parsley is a biennial which flowers the second year and sets seed. Let the seed heads dry, and gather for sowing next year. If Parsley is grown in the garden, just let the mature seeds drop and the seedlings will volunteer the next year. I have grown thyme, oregano, sage, cilantro and even tarragon with much success. One note is that cilantro does not last too long in our summer heat, but you can sow a succession of seed every couple of weeks and you will always have plenty for your favorite Mexican dishes. Another tip about herbs is that the more you pick them the bigger they grow which means more to harvest and share with friends. Pick the herbs very early in the morning for the most robust flavors, then keep their stems in a glass of water until time of use. Butterflies and bees, plus beneficial insects are very attracted to all types of herbs. So love a butterfly and plant herbs.

### **ROUND UP WARNING.**

Today it is recommended to use this chemical sparingly, so what can we do about weeds besides man handling them out of the ground. Recent research shows there is a more environmentally safe spray that after one or two applications was as effective as Round Up and much cheaper. It is **COMMON VINEGAR** which has about 5 percent acetic acid. Vinegar was pitted against the commercial acetic-acid-based weed killers named Nature's Glory Weed and Grass Killer, and BurnOut Weed and Grass Killer. The research plots were sprayed three times, and all the weed killers tested showed a 95 percent control, including common table vinegar. However, for best results one would need to reapply every five weeks for best control.

## Reeltown Veterans Transition into Farming

Let me introduce myself. My name is Dawn Smith. My husband Tim and I are both Air Force retirees who now own and operate Lone Oak Farm in Liberty City, AL. At Lone Oak, we produce purebred Black Angus freezer beef and delicious, healthy vegetables. Earlier this spring, I transitioned from a full-time job in the public sector to full-time farming. In addition to farming, Tim is the Senior Pastor at First Baptist Church Reeltown. Tim grew up on a farm and has had a longing to one day own one. I can't say the same for myself. I hated weeding the garden when I was a kid so the fact that I'm now in full-time farming is hilarious to my parents. The Green Acres theme song keeps coming to mind. That being said, the past several months have been such a learning experience. Anyone who knows the two of us knows that Tim is full of adventures and I am all about life-long learning.

As a result of our newest adventure, we were invited to Capitol Hill to discuss issues relating to military veterans pursuing careers in agriculture. On July 11th & 12th, we joined a contingent of approx-

imately 28 other veterans from across the nation. We all had the common purpose of explaining to Congressmen and Senators some of the hurdles and successes we have faced as we've transitioned from military careers to agricultural related fields. The trip gave us the opportunity to be heard, make connections, as well as, hear from policy makers about issues they are currently working on to aid veterans in agriculture. We were addressed by numerous committee leaders to include Texas Congressman Mike Conaway, the Chairman of the House Agriculture Committee; Senator Pat Roberts, Chairman of the Senate Agriculture Committee and Senator Johnny Isakson, Chairman of the Senate Veteran's Affairs Committee, just to name a few. The topic at the forefront of most of the discussions was the 2018 Farm Bill. We even got to meet privately with Congressman Mike Rogers, our district Representative, who has recently been selected as a Conferee for the 2018 Farm Bill. We feel like these legislators listened to what we had to say and will draw from those conversations relating to military veterans and agriculture.

One of the most exciting parts of the trip was when we took part in the unveiling of an updated Homegrown by Heroes marketing label. "The **Homegrown By Heroes** label is the official farmer veteran branding program of America..." per the Farmer Veteran Coalition website. This marketing campaign and the entire trip was a collaborative effort of Farm Credit and the Farmer Veteran Coalition. The new logo was updated to add in the silhouette of a female service member in addition to the previously depicted male service member. I love the new logo, especially in light of the fact that we female service members are many times overlooked when it comes to symbolism representing the military. In May of 2018, Lone Oak Farm became certified to use the Homegrown By Heroes label, to let folks know that not only are they purchasing locally grown products but they are also supporting military veterans.

The trip wrapped up with a session at the United States Department of Agriculture (USDA) where we heard from and had an open forum question and answer period with Deputy Secretary of Agriculture Stephen Censky. During this session we expressed our appreciation for things like the Natural Resources Conservation Service (NRCS) grants system and expressed our frustrations with some of the requirements and regulations USDA that are possibly outdated and a hindrance to military veterans successfully pursuing agriculture careers. The folks at USDA will hopefully listen and seek ways to implement strategy changes.

Tim and I both felt humbled to be invited on the trip and are certainly appreciative of all the opportunities to represent Alabama and veterans in the agriculture community. We have to say a huge "Thank you" to the Farm Credit System for their financial support of the Homegrown By Heroes label. Specifically, we'd like to thank Alabama Ag Credit for sponsoring our trip and for all the help they've given us in our farming endeavor. Another "Thank you" goes out to the non-profit, Farmer Veteran Coalition connecting military veterans with agricultural education, grants, mentorship programs and of course, the Homegrown By Heroes marketing campaign. Not only do these two organizations see the need to encourage folks to go into agriculture, they understand that things like "tractor time" and digging in the dirt are therapeutic. They give veterans a chance when other traditional agencies won't take the risk. They truly understand that careers in agriculture are a natural fit for so many veterans on so many different levels and are doing what they can to facilitate that transition.

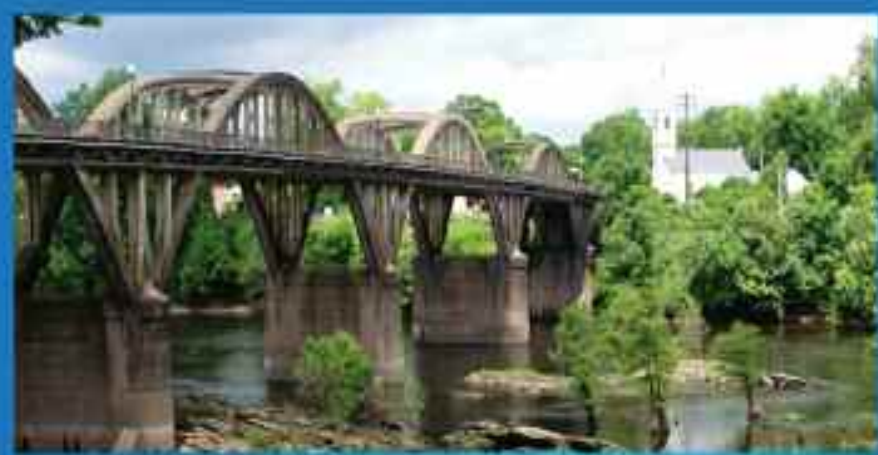

# Soul Searching

## Forgiveness: Is It Optional ?

**Do you have someone you need to forgive? We all do!**

Perhaps, someone has wronged you recently or in the past. Maybe you have experienced being lied about, betrayed, sabotaged, undermined, misquoted, left out, used, exploited, intentionally hurt, physically harmed, sexually abused, emotionally damaged or sinned against in some way.

Maybe you can think of someone right now that you really don't think you can ever forgive. In fact, you really don't want to forgive them. Deep down (maybe no one even knows but you) you harbor bitterness, anger, hate, and unforgiveness.

**Jesus tells us we must forgive others regardless of what they have done to us. He doesn't make it optional.**

*"For if you forgive other people when they sin against you, your Heavenly Father will also forgive you. But if you do not forgive others their sins, your Heavenly Father will not forgive your sins."* - Jesus, Matthew 6:14-15

And the Apostle Paul also says to us we must forgive as freely as Jesus has forgiven us. Again, it doesn't appear to be optional.

*"Be kind and compassionate to one another, forgiving each other just as in Christ God forgave you."* - Paul, Ephesians 4:32

**Why Forgiveness isn't optional!**

**First, we should forgive others because God has forgiven us.** Paul says this so well in Ephesians 4:32. God has extended his amazing grace to us, and we are called to extend that grace and forgiveness to all those who have wronged us or sinned against us. Forgive as freely as Christ has forgiven you. Did you know you will never be asked to forgive anyone more than God has already forgiven you? That is a hard pill to swallow, but I believe if you pray about this and reflect on it, you will agree that it is true. Forgive because you have been forgiven!

**Second, we must forgive, because we will need to be forgiven in the future. Jesus is clearly making this point in Matthew 6:14-15.**

Someone came to John Wesley once about the issue of forgiveness. The man told Wesley he could never forgive this particular person for the hurt and pain they had caused him. John Wesley had a surprising response. He said, "well, I hope you never sin again." The man said what do you mean? Wesley answered, "your bitterness, anger and lack of forgiveness will burn the bridge upon which your forgiveness will come in the future." In the Lord's Prayer, Jesus teaches us to pray, *"forgive us our sins, as we forgive those who sin against us."*

**Forgiveness is clearly a core teaching of Jesus.** We have been forgiven by God through Jesus Christ. He paid the price for our sins by his death on the cross. And therefore, we are to freely offer forgiveness to others, because we have experienced God's forgiveness. In fact, our own forgiveness for future

sins against God and other people is dependent upon how we live out offering forgiveness to others.

Therefore, the call by Jesus for us to forgive others is not optional. Whether we feel like it or not. Whether we want to or not. Whether we think we can or not. We must forgive others who have intentionally or unintentionally wronged us.

**What forgiveness is Not**

Forgiveness is not saying that what happened to you doesn't matter. Forgiveness in no way minimizes the the seriousness of the sin against you. The fact that you need to forgive them means that it was serious and that it did matter.

Forgiveness does not mean that you have to trust that person or that you must resume the relationship with them without some changes. Forgiveness and restoration are two different things. You can forgive someone and not necessarily restore the relationship. It should be a goal to be reconciled to them if possible. But restoration and reconciliation require trust. And trust must be earned or re-earned over time. Most of the time, if possible, we should seek restoration or reconciliation with the person who wronged us. However, there are certain people and particular cases where we should not seek to restore the relationship. If fact, there are some people we need to forgive and then separate ourselves from them and move on.

Forgiveness is not forgetting what happens to you. The Bible never says forgive and forget. The truth is you may never forget it. The key is not to forget but to focus on God's love for you and for the person who wronged you. Focus on God's power to bring good out of what was others may have intended for harm. God never causes evil to happen to us, but God can use any and all situations for our good in the long run to strengthen us and to use us to help others in the future.

**Finally, forgiveness is not dependent on the person who wronged you.**

They may never ask for forgiveness. But you can forgive them anyway. They may not be present for you to tell them you forgive them. They may have moved away. They may be dead. You may not have any idea where they are now or how to contact them. But it doesn't matter. You can forgive them. It is not conditional on their response in any way. So, whether they ask for it, accept it, receive it, or know about it .... it doesn't matter. This is primarily between you and God. Now there are many cases where you might want to share with that person that you have forgiven them. And, in some cases, they need to hear that and know that. But you forgiving another person is not dependent or conditional upon their response. I have found that this truth is very freeing to many people and helps them on the journey of forgiveness!

**Forgiveness is not optional.**

**But we will need God's help and God's grace to be able to offer it!**
