### THE INTERNATIONAL DIANTHUS REGISTER (1983) & CHECKLIST

## **TWENTIETH SUPPLEMENT**

The following list contains the names of *Dianthus* cultivars registered between 1 January 2002 and 31 December 2002.

Raisers and introducers of cultivars of *Dianthus* are urged to ensure that the names of all their plants have been registered and are reminded that registration should take place <u>before</u> a plant is released or the name is mentioned in print. Registration concerns <u>all</u> named cultivars. Registration forms can be obtained from the International Dianthus Registrar, Royal Horticultural Society's Garden, Wisley, Woking, Surrey GU23 6QB, England who will issue a certificate of registration on request. There is no fee.

The format of entries follows a pattern first adopted in the Fifth Supplement. Following the classification and name of each new cultivar a statement regarding parentage or origin is given in parenthesis. The names of those involved in the raising, introduction and registration of the plant are then given, together with relevant dates ( $\mathbf{R}$  = raiser,  $\mathbf{H}$  = hybridizer,  $\mathbf{G}$  = grown to first flower by,  $\mathbf{S}$  = selected by,  $\mathbf{N}$  = named by,  $\mathbf{I}$  = introducer, <u>REG</u> = registrant,  $\mathbf{L}$  = listed by). When a date is given after a colon and without a name (e.g. <u>REG</u>: 1987) it can be assumed that the individual or firm involved is that immediately preceding it, e.g. <u>R</u> (1982) & I (1983): A. Smith <u>REG</u>: 1984 implies that the plant was raised by A. Smith in 1982, introduced by him in 1983 and registered by him in 1984.

Perpetual carnations are listed, where known, as sprays or standards. The use of the latter should not be confused with the citation of Nomenclatural Standards which refer to individual herbarium specimens or images (slides, prints etc.) which have been selected as the definitive point of reference should any doubt arise about the plant to which the name concerned should be applied.

Colour references such as 128D are to the RHS Colour Chart (1966, 1986, 1995, 2001), those such as 730/3 refer to the Horticultural Colour Chart (1941). The descriptions are as full and consistent as information provided by the registrant and other sources allows. Any additional material would be welcomed by the Registrar.

This publication is styled both as a Register and Checklist. As such it contains not only the most recent new registrations, but details of other plants for which information is available even though their names are not formally registered. Where these names would not be acceptable for registration this is indicated and reference given to the relevant Article of the *International Code of Nomenclature for Cultivated Plants - 1995*. Those most frequently cited here are: Art. 17 which deals with the formation of cultivar epithets and Art. 26 which discourages the re-use of names.

### (b) 'Ada Ellen'

cv. ('Robert Smith', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls fully double, 75mm wide, white ground, with a discontinuous red wire edge and sparse, vertical, red bars down centre of each petal; margins entire; not scented. Strong stems, 90cm (under glass). (More heavily marked than 'Robert Smith'. Nomenclatural Standard: colour slide provided by registrant (WSY 0034880). Etymology: named for a Mrs Ada Ellen Moorhouse.)

### (p) 'Alan Morgan Davies'

cv. ('Oakwood Gillian Garforth' (s) × 'Anders Dorothy Wilson'). H: A.J. Derrick (1999), G: A.J. Derrick (2000), N: A.J. Derrick (2002), I: A.J. Derrick (2002), REG: A.J. Derrick (2002). Fls fully double, 45mm wide, deep red (53A) self; margins very shallowly toothed; slightly scented. Lvs dark blue-green. Stems 26cm (under glass). (Nomenclatural Standard: colour print provided by registrant (WSY 0033473). Named for the late husband of Diana Davies, a secretary at RHS Garden, Wisley.)

### (p) 'Albion Monarch'

cv. ('Albion Rose-Lion' (s) × 'King's Cardinal'). H: M. Romang (2000), G: M. Romang, N: M. Romang, I: M. Romang, REG: M. Romang (2002). Fls semi-double, 25mm wide, ground dark red (187B), with a narrow rim of deep purplish pink (73A) and a spot of the same colour which may take up a large part of the petal limb (but is variable in size); margins toothed; scented. Lvs narrow, stiff, silvery green, c40mm long. Sparse but compact habit, with stems 80-100mm. Flowering over a long season (up to October). (Nomenclatural Standard: colour print provided by registrant (WSY 0034941).)

## (p) 'Anders Pamela Ross'

cv. ('Anders Tia' (s) × 'Welton Star'). H: A.J. Derrick (1998), G: A.J. Derrick (2000), N: A.J. Derrick (2002), I: A.J. Derrick (2002), REG: A.J. Derrick (2002). Fls single, 50mm wide, ground very pale purple (69B), with a broad eye zone of moderate purplish red (70A) whose outer margin is broken up into a zone of streaks and spots and with the petal margins towards the base narrowly edged with the ground colour; apical margins very shallowly toothed; slightly scented. Lvs glaucous blue-green. Stems to 35cm (under glass). (Nomenclatural Standard: colour print provided by registrant (WSY 0033473). Named for Mrs Pamela Ross, the sister of Joseph Miao who is the partner of Caroline Hall, secretary to the International Dianthus Registrar.)

## (b) 'Anne S. Moore'

cv. (Un-named picotee × un-named picotee). H: J.G. Moore (1999), G: J.G. Moore (2001), N: J.G. Moore (2001), REG: J.G. Moore (2002). Fls fully double, 75mm wide, ground light red, with a wire edge picotee; not scented. Stems 50cm (under glass).

## (b) 'Arlene'

See note under 'Arline'.

#### (b) 'Arline'

cv. ('Lord Nuffield' × 'Yorkshireman'). R: J.W. Hubbard (c 1988), N: J.W. Hubbard. Fls with a grey ground, striped red. (An unacceptable name, Art. 26.1. Also seen as 'Arlene')

#### (p) 'Asshawes Harmony'

cv. ('Anders Patricia Griffiths' (s) × 'Belmont Ruby Wedding'). H: H. Dolderson (2000), G: H. Dolderson (2001), N: H. Dolderson (2001), I: H. Dolderson (2002), REG: H. Dolderson (2002). Fls single, 50mm wide, ground pure white, with a clearly marked deep claret (close to 187C) eye and narrow claret lacing (the extreme margin a little paler); margins more-or-less entire; scented. Lvs glaucous green. Stems 45cm (under glass). (Nomenclatural Standard: colour slide (WSY 0033420) provided by registrant. Etymology: "Asshawes" is where the registrant lives, "Harmony" is made up of letters from the names of the registrant and his wife (Harry and Norma).)

# (p) 'Bayer Heden'

cv. ('Culcheth White Lady' × unknown). H: B. Heden (2000), G: B. Heden (2001), N: B. Heden (2001), I: B. Heden (2001), REG: B. Heden (2002). Fls an open-centred double, 25-30mm wide, ground white, with a yellow zone at base which has an apical reddish band (the yellow and red fading to leave a lilac marking); margins with sharp, irregular, mostly shallow teeth; very strongly carnation-scented. Lvs blue-green. Stems 12cm (under glass), of rather straggly habit. (Nomenclatural Standard: colour print provided by the registrant (WSY 0035262). Etymology: named for the registrant's mother.)

# (b) 'Betty's Yellow'

cv. ('Aldridge Yellow' (s)  $\times$  un-named yellow seedling). H: P.W. Russell (1995), G: P.W. Russell (1996), N: P.W. Russell, REG: P.W. Russell (2002). Fls fully double, 90mm wide, pale yellow self; margins virtually entire; not scented. Strong stems to 1.0m or more (under glass). (Similar to 'Spinfield Yellow' but a brighter yellow and a smooth-edged petal. Nomenclatural Standard: colour print provided by registrant (WSY 0031320). Etymology: Betty is the christian name of the registrant's wife.)

# (p) 'Blauer Teppich'

cv. (gratianopolitanus seedling × subacaulis). R: J. Stinglhammer (1997), N: J. Stinglhammer (1999), REG: J. Stinglhammer (2002). Fls single, 25mm wide, light pink ground, with a ring of red dots around the eye; margins sharply toothed. Lvs blue-grey. Stems 120-150mm. Plants form dense cushions. Late May-mid June. (First published in ISU Yearbook 2000. Nomenclatural Standard: colour print provided by registrant (WSY 0040242).)

# (b) 'Braeside Crimson'

cv. (Parentage unknown). R: J.G. Moore (pre- 2002), N: J.G. Moore. Fls 100mm wide, deep crimson self. (Etymology: Braeside is the name of the raiser's house.)

## (b) 'Braeside White'

cv. (Parentage unknown). R: J.G. Moore (pre- 2001), N: J.G. Moore. Fls white self. (Etymology: Braeside is the name of the raiser's house.)

# (p) 'Chesswood Angela Avery'

cv. ('Chesswood Emily Jane', open-pollinated). H: D.J. Cottam (2000), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls single, 25mm wide, red ground, with two large, apically lobed, pink patches on each petal and an irregular, narrow, pink margin; margins deeply and sharply toothed; scented. Stems 14cm (under polytunnel protection). (Nomenclatural Standard: colour print provided by registrant (WSY 0034895). Etymology: named for a visitor who admired the registrant's plants on the British National Carnation Society's stand at a show in the National Exhibition Centre.)

# (p) 'Chesswood Ann Rhodes'

cv. ('Chesswood Sandilands' (s) × 'Chesswood Jinny Moore'). H: D.J. Cottam (1997), G: D.J. Cottam (1998), N: D.J. Cottam (1998), I: D.J. Cottam (1999), REG: D.J. Cottam (2002). Fls single, 25mm wide, pinky white ground, eyed, laced and with a central vertical bar of red on each petal; margins entire; scented. Lvs grey-green. Stems 25cm. (Taller than 'Chesswood Sandilands' and with more prominent lacing. Nomenclatural Standard: colour print provided by registrant (WSY 0034890). Etymology: named for the late mother of a customer of the registrant. First published in Doug Cottam Pinks & Carnations catalogue, 2000.)

### (b) 'Chesswood Barbara Arif'

cv. ('Spinfield Lane', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls fully double, 65mm wide, white ground, with a red, wire-edged picotee; margins entire; not scented. Vigorous plant, with stems 84cm (under glass). (Nomenclatural Standard: colour slide provided by registrant (WSY 0034882). Etymology: named for a friend of the registrant.)

### (b) 'Chesswood Carol Ann'

cv. ('Hilda Clark', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2001), N: D.J. Cottam (2002), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls fully double, 80mm wide, yellow ground, ticked, edged and suffused cerise; margins entire, slightly waved; slightly scented. Stems strong, 84cm (under glass). (Nomenclatural Standard: colour print provided by registrant (WSY 0034897). Etymology: named for daughter-in-law of Mrs Joan Ashby, a cousin of the registrant's wife.)

## (p) 'Chesswood Emily Jane'

cv. ('Chesswood Jinny Moore' (s) × 'Whatfield Teresa Turk'). H: D.J. Cottam (1999), G: D.J. Cottam (2000), N: D.J. Cottam (2000), I: D.J. Cottam (2000), REG: D.J. Cottam (2002). Fls single, 22mm wide, red ground, with 1-2 irregular pink patches on each petal (very variable in size and shape), eye zone a little darker; margins shallowly toothed; scented. Lvs grey-green. Very bushy habit; stems 14cm (under glass). Very floriferous. (Nomenclatural Standard: colour print provided by registrant (WSY 0034892). Etymology: named for the registrant's granddaughter. First published in Doug Cottam Pinks and Carnations catalogue, 2001.)

## (p) 'Chesswood Jack William'

cv. ('Double North' (s) × 'Chesswood Sandilands'). H: D.J. Cottam (2000), G: D.J. Cottam (2001), N: D.J. Cottam (2002), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls semi-double, with an open centre, 32mm wide, ground white, with a yellow eye which is ticked red, edged pink and has a hint of green; margins very shallowly toothed; strongly scented. Lvs glaucous green. Stems strong, self-supporting, 20cm (under polytunnel protection). PC 2002. (Nomenclatural Standard: colour print provided by registrant (WSY 0034896). Etymology: named for the registrant's grandson.)

#### (p) 'Chesswood Jane Parker'

cv. ('Chesswood Jinny Moore' (s) × 'Whatfield Silver Lining'). H: D.J. Cottam (1999), G: D.J. Cottam (2000), N: D.J. Cottam (2000), I: D.J. Cottam (2001), REG: D.J. Cottam (2002). Fls single, 30mm wide, pale pink ground (typically showing as a very narrow margin and two large spots on each petal), otherwise burgundy, with a pink band outside the darker lacing; margins shallowly toothed; scented. Lvs glaucous green. Stems 20cm (under polytunnel protection), with 3 fls. PC 2002. (Nomenclatural Standard: colour print provided by registrant (WSY 0034888). Etymology: named for a hotel manageress in Gateshead.)

## (p) 'Chesswood Joan Ashby'

cv. ('Kesteven Kirkstead', open-pollinated). H: D.J. Cottam (1994), G: D.J. Cottam (1995), N: D.J. Cottam (1995), I: D.J. Cottam (1995), REG: D.J. Cottam (2002). Fls single, 50mm wide, ground purplish pink, with a dark claret eye; margins with irregular, shallow but sharp teeth; scented. Foliage glaucous green, compact. Stems 20cm (in the open ground). (Nomenclatural Standard: colour slide provided by registrant (WSY 0034887). Etymology: named for a cousin of the registrant's wife.)

#### (p) 'Chesswood Jo Jo'

cv. ('Oakwood Setting Sun', open-pollinated). H: D.J. Cottam (1998), G: D.J. Cottam (1999), N: D.J. Cottam (1999), I: D.J. Cottam (2001), REG: D.J. Cottam (2002). Fls

single, 45mm wide, pink ground, with a deep burgundy eye which is surrounded by a paler halo so highlighting the eye; margins very shallowly toothed; scented. Lvs greygreen. Upright stems, 25cm (under polytunnel protection). (Nomenclatural Standard: colour side provided by registrant (WSY 0034886). Etymology: named for a friend of the registrant's granddaughter. First published in Doug Cottam Pinks and Carnations catalogue, 2001.)

## (p) 'Chesswood Kathy Garmonsway'

cv. ('Chesswood Emily Jane', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2000), N: D.J. Cottam (2001), I: D.J. Cottam (2001), REG: D.J. Cottam (2002). Fls single, 25mm wide, pink ground, heavily mottled and overlaid deep pink, usually with two moderate-sized pale patches and some smaller pale spots and a narrow pale edge; margins unevenly toothed; scented. Bushy growth; stems 12cm (under polytunnel protection). (Nomenclatural Standard: colour print provided by registrant (WSY 0034893). Etymology: named for a visitor who admired this seedling when exhibited on the British National Carnation Society's stand at a show at the National Exhibition Centre.)

## (b) 'Chesswood Laura Chow'

cv. ('Maisie Neal', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls fully double, 75mm wide, mauve ground, suffused grey; margins entire; not scented. Strong stems, 84cm (under glass). (Similar in colour to 'Leslie Rennison' but more vigorous and with a stronger 'neck'. Nomenclatural Standard: colour slide provided by registrant (WSY 0034881). Etymology: named for a family friend of the registrant.)

## (b) 'Chesswood Margaret Alison'

cv. ('Spinfield Lane', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls fully double, with a high crown, 75mm wide, old rose self, margins entire or with a few shallow teeth; heavily clove-scented. Lvs grey-green. Stems 91cm (under glass). (Nomenclatural Standard: colour slide provided by registrant (WSY 0034884). Etymology: named for a friend (and the next door neighbour) of the registrant.)

# (p) 'Chesswood Niamh Ann'

cv. ('Whatfield Teresa Turk', open-pollinated). H: D.J. Cottam (1999), G: D.J. Cottam (2000), N: D.J. Cottam (2000), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls single, 25mm wide, ground pale lilac/lavender, suffused and delicately ticked deeper lilac and with an inconspicuous deeper eye; margins toothed; scented. Erect stems, 14cm (under glass). (Similar to 'Whatfield Joy' but a more delicate colour. Nomenclatural Standard: colour slide provided by registrant (WSY 0034883). Etymology: named for the daughter of the hairdresser of the registrant's wife.)

# (p) 'Chesswood Rachel Elizabeth'

cv. (Parentage unknown). H: D.J. Cottam (2000), G: D.J. Cottam (2001), N: D.J. Cottam (2001), I: D.J. Cottam (2002), REG: D.J. Cottam (2002). Fls single, 40mm wide, delicate lavender self; margins slightly toothed; scented. Lvs grey-green, slender. Stems 25cm (under glass). Vigorous and floriferous. (Nomenclatural Standard: colour slide provided by registrant (WSY 0037514). Etymology: named for daughter of registrant's next door neighbour.)

# (p) 'Culcheth Delight'

cv. ('Glazebury Frosted Princess' × 'Glazebury Frosted Princess'). H: W.B. Heden (2001), G: W.B. Heden (2002), N: W.B. Heden (2002), REG: W.B. Heden (2002). Fls single with broadly overlapping petals, 25-30mm wide, mid dusky pink ground, with a large cherry red eye; margins entire (or minutely toothed); scented. Lvs blue-green. Stems 10cm (under glass), making a fairly compact plant; similar to 'Glazebury Frosted Princess' but paler and with more compact foliage. (Nomenclatural Standard: colour print provided by registrant (WSY 0035256).)

#### (p) 'Culcheth Fuchsia Queen'

cv. ('Rachel' × 'Rachel'). H: W.B. Heden (2000), G: W.B. Heden (2001), N: W.B. Heden (2002), REG: W.B. Heden (2002). Fls single, 25mm wide, with broadly overlapping rounded petals, ground a fluorescent, vivid reddish purple (near 74A), with a slightly darker eye; margins entire (or minutely toothed); slightly scented. Lvs blue-green. Stems 12.5cm (under glass). (Nomenclatural Standard: colour print provided by registrant (WSY 0035259). The origin of the 'Rachel' parent is unknown: it was not the Allwood cultivar 'Rachael', but an "alpine pink", with single deep pink flowers.)

### (p) 'Culcheth Splendour'

cv. ('Pixie Star' (s) × 'Whatfield Joy'). H: W.B. Heden (1999), G: W.B. Heden (2000), N: W.B. Heden (2002), REG: W.B. Heden (2002). Fls single, 25-30mm wide, ground pink at first fading to shell pink, with a distinct red eye (with a sharp but irregular apical margin, diffused on basal side); margins waved, shallowly and irregularly serrate; scented. Lvs blue-green. Stems 10cm (under glass), 6cm (in the open); bushy habit. (Nomenclatural Standard: colour print provided by registrant (WSY 0035255).)

### (p) 'Culcheth White Supreme'

cv. (Pink sport from 'Dewdrop' (s) × 'Culcheth White Lady'). H: W.B. Heden (2001), G: W.B. Heden (2002), N: W.B. Heden (2002), REG: W.B. Heden (2002). Fls semidouble to double, 30mm wide, white self; margins with irregular, sharp teeth; scented. Lvs almost green (slightly grey-tinged). Stems 12cm (under glass). Similar to 'Dewdrop' but with larger, fuller flowers, less teeth on the petals and greener foliage. (Nomenclatural Standard: colour print provided by registrant (WSY 0035254).)

## (p) 'Dazzler'

cv. (Parentage unknown, probably involving *gratianopolitanus*). L: Bluestones Perennials (USA) (1994). Fls single, dazzling rose pink, with frayed petal edges. Foliage blue-green. Stems to 125mm. (An unacceptable name, Art. 26.1.)

#### (b) 'Diana Hall'

cv. (Parentage unknown). R: S. Hall (1985), N: S. Hall. Fls with a white ground, edged and marked magenta.

#### (b) 'Ellen Jones of Wattstown'

cv. ('Pennine Mist' (s) × 'Alfred Galbally'). H: S. Wilson (1999), G: S. Wilson (2000), N: S. Wilson (2002), REG: S. Wilson (2002). Fls fully double, 70-75mm wide, lavender grey self; margins entire; clove-scented. Lvs 5mm wide. Good strong grower, with an erect habit. Stems 68cm (in the open). (Nomenclatural Standard: colour print provided by registrant (WSY 0035144). Etymology: named for the wife of the late Emyln Jones who was a National Service billet mate of the raiser in Mafraq, Jordan.)

## (b) 'Emlyn Jones'

cv. ('Yorkshireman' (s) × 'Jane Coffey'). H: S. Wilson (1995), G: S. Wilson (1997), N: S. Wilson (2002), REG: S. Wilson (2002). Fls fully double, 70-75mm wide, white ground, edged and marked with scarlet; margins entire; not scented. Foliage and habit similar to 'Yorkshireman'; lvs blue-green. Stems 64cm. (Nomenclatural Standard: colour print (WSY 0035135), provided by registrant. Etymology: the late Emlyn Jones was a National Service billet mate of the registrant in Mafraq, Jordan.)

#### (b) 'Graham's Fancy'

cv. (Parentage unknown). R: J.G. Moore (pre- 2001), N: J.G. Moore. Fls 100mm wide, white ground, striped light red.

# (p) 'Harry Oaks'

cv. (Parentage unknown). L: Kingstone Cottage Plants (2000). Fls double, very pale pink ground, with a darker eye; scented. Robust. (Etymology: named after the father of a Kingstone Cottage Plants customer. An unacceptable name, Art. 17.13.)

# (p) 'Itsy Bitsy'

cv. (Un-named seedling  $\times$  un-named seedling). H: P.L. Russell (2000), G: Mills Farm Plants (2001), N: Mills Farm Plants (2002), I: Mills Farm Plants (2003), REG: Mills Farm Plants (2002). Fls single, 10mm wide, magenta pink self; margins entire; not scented. Lvs greyish green. Very compact habit, with stems 50mm tall (in the open). (Nomenclatural Standard: colour slide provided by registrant (WSY 0034943).)

## (b) 'Jill Ann'

cv. (Parentage unknown). R: J.G. Moore (pre- 2002), N: J.G. Moore. Fls with a white ground, marked and striped deep red. (An unacceptable name, Art. 26.1; an unfortunate re-use by the same raiser. The earlier listing, as 'Jill Anne', was mis-spelt and should also be 'Jill Ann'.)

# (p) 'Lauren's Tutu'

cv. ('Becky Robinson', open-pollinated). H: F. Wynn (1999), G: F. Wynn, N: F. Wynn (2000), REG: F. Wynn (2002), I: D.J. Cottam (2001). Fls fully double, 45mm wide, ground pale pink, laced deep pink and with a deep pink eye; margins toothed; scented. Lvs unusually broad, grey-green. Stems 34cm (under glass). Plant of compact habit. (Etymology: named for registrant's granddaughter (Lauren Bretton). First published in Doug Cottam's catalogue, 2001. Sometimes seen incorrectly as 'Lauren's Tu Tu' or 'Lauren's Tu-Tu'. Nomenclatural Standard: pressed petals supplied by registrant (WSY 0034977).)

# (p) 'Linfield Romy Stringer'

cv. (Parentage unknown). G: J. Linnell (1996), N: J. Linnell (2000), I: J. Linnell (1999), REG: J. Linnell (2002). Fls fully double, white ground, eyed and laced scarlet, the lacing with an irregular inner margin; margins entire; strongly scented. Petals more-or-less flat, not strongly waved. Lvs grey-green. Stems 15cm (under glass); lax habit. (Nomenclatural Standard: colour print provided by registrant (WSY 0034929). Etymology: named for a daughter of an acquaintance of the registrant.)

## (b) 'Maisie Trenaman'
